Privacy of Information Statement

Homerun Investments Inc has created this privacy statement in order to demonstrate our firm commitment to the safe, secure, and responsible handling of information provided by our members. The following discloses our information gathering and dissemination practices for our mentoring program.

Our mentoring program and workshop registration forms require users to give us contact information (like their name and email address). We use customer contact information from these forms to send the user information about our company and details about our training events.

The customer's contact information is also used to contact the customer when necessary. Users may opt-out of receiving future mailings. (See the choice/opt-out section below.) Financial information that is collected is used to bill the user for products and services.

Due to the nature of the mentoring program we may, from time to time, need to pass on contact information within the group to facilitate the training requirements of the program. We do not pass this information on to any persons outside of the membership group.

Under no circumstances do we sell or distribute in any way any of the information collected on our membership forms.

Credit Card or Financial Information Protection

For the protection of our members we employ the use of a Third party payment system such as Moneris. This allows the user the highest security. Credit card or financial information is absolutely secure and is held in the strictest of confidentiality. We will not for any reason release this information to anyone but the stated card or account holder unless we have prior written authorization to do so.

When we confirm a person's use of credit card information, we do not include the credit card number or any other financial information in our reply e-mail. While we can be assured of our own security system, we do not always know what is in place at the client end.
